

## How do Haskayne alumni access business information after graduation?

### Alumni Cards

- As a graduate of the University of Calgary you automatically become a member of the Alumni Association. You may have received a gold Alumni card or an Alumni benefits card with your name and alumni # on it
- Alumni membership is a free, lifelong membership
- To enhance your Alumni privileges you will need to obtain an *Alumni UNICARD*, which gives you library privileges and Campus Recreation discounts

### Alumni Library Privileges

- Your *Alumni UNICARD* is your library card
- After you receive your *Alumni UNICARD* you will need to add library borrowing privileges. Adding Library borrowing privileges can be done at any U of C library branch.
- At no-cost you can borrow up to 50 books from the different library branches at the University of Calgary. You will have a two week loan period on your **books** and you can renew them as long as there are no holds.
- The *Alumni UNICARD* also contains a strip that will allow you to add money to your card for **printing** on campus
- Alumni are able to access almost all **databases** while **on campus**. For branches that require a computer login, a guest pass is available from the TFDL 2<sup>nd</sup> floor Tech desk, Phone 220-5239

Find articles and data from Statistics Canada Census and socio-economic data.
- [Conference Board of Canada](#)  
E-Library contains reports and projections about the Canadian Economy and key industries in Canada. Also covers areas of Organizational Performance and Public Policy.
- [OECD iLibrary](#)  
The online library of the Organization for Economic Co-operation and Development. Extensive statistical resources, economic indicators, country tables and more. Many of these resources are publicly available.

The International Monetary Fund publishes a range of time series data on IMF lending, exchange rates and other economic and financial indicators.
